

FACTS	WHAT DOES PORSCHE FINANCIAL SERVICES (PFS) DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or services you have with us. This information can include: <ul style="list-style-type: none"> • Social Security number and transaction history, • Income and account balances, • Payment history and credit history.
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons PFS chooses to share; and whether you can limit this sharing.

Who is providing this notice	Porsche Financial Services, Inc. (dba - Bentley Financial Services, Lamborghini Financial Services and Bugatti Financial Services), and Porsche Leasing Ltd.
What we do?	
How does PFS protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does PFS collect my personal information?	We collect your personal information, for example, when you: <ul style="list-style-type: none"> • Apply for a lease or apply for financing, • Pay your bills or open an account, • Give us your contact information. We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only: <ul style="list-style-type: none"> • Sharing for affiliates' everyday business purposes - information about your creditworthiness. • Affiliates from using your information to market you. • Sharing for nonaffiliates to market you. State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> • <i>Our affiliates include nonfinancial companies, such as automotive manufactures with a common corporate identity with the financial institution providing this notice; and other direct and indirect subsidiaries of the financial institution providing this notice.</i>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> • <i>Nonaffiliates we share with can include motor vehicle dealers that sell, finance, and service new and previously owned vehicles through Porsche Financial Services, Inc. and other nonaffiliated companies as permitted by law.</i>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> • <i>Our joint marketing partners include financial service providers, such as banks, insurance companies, and motor vehicle dealers.</i>

Other important information	
FOR NORTH DAKOTA CUSTOMERS: Porsche Financial Services will not disclose nonpublic personal information to any nonaffiliated third party, except as otherwise permitted by law.	
FOR VERMONT CUSTOMERS: We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
